

Agreement on Ticket Distribution Services

Annex 2

## TERMS

The Parties hereby agree that the following capitalised terms, as used in the Agreement and other documents which are deemed to form an integral part of the Agreement, shall be defined as follows.

Deed of Settlement	Once the Event has taken place, the Distributor shall provide the Organiser with a Deed of Settlement/Reconciliation, which shall be considered as the basis for settlement between the Parties. The Deed of Settlement shall indicate the quantity of Tickets sold and the amount of money received for the Tickets sold.
Ticket	It means a document generated and printed by the System which grants the right of access to a specific event and which specifies the particular name of the event, where and when it takes place, the seat in the venue, the organiser of the event, the price of the ticket and the BAR code.
Agreement	Agreement on Ticket Distribution Services signed by the Parties, its annexes, other documents which are not annexes to the Agreement on Ticket Distribution Services, but which are concluded on the basis of it and which are related to the relationship of the Parties under the Agreement on Ticket Distribution Services.
Electronic Ticket Reservation and Distribution System or System	It means the Distributor's electronic ticket reservation and distribution system, as a copyright object, which operates through an Internet connection.
E-ticket	It means a Ticket purchased on the Website www.bilietai.lt, which is paid for by means of the tools provided by banks for payment in e-shops, including, but not limited to, e-banking and bank payment cards.
Website	It means the e-shop operated by the Distributor at www.bilietai.lt, where the Customer can order and/or purchase a ticket for the desired event online. The ownership of the Website is owned by the Distributor and forms an integral part of the System.
Event	An event organised by the organiser.
Plan of the Venue	A graphical representation of the venue (room or marked area), including seat numbering and pricing.
Customer	A person who intends to purchase or has already purchased a Ticket for an Event.
Organiser's Module	A tool for Event Organisers to view ticket sales indicators for their events, as well as to book tickets, apply relevant discounts and perform other actions as allowed by the Organiser Module.
Invitation	A ticket for a specific event with a 100% discount.
The Commission Fee	The fee payable to the Distributor by the Organiser for the Ticket distribution services provided.
Service	Ticketing service provided by a Distributor.

Service Fee	The fee payable by the Customer to the Distributor for the provision of information, generation and/or printing of the requested Ticket shall be the Distributor's revenue.
VAT Invoice or Invoice	VAT invoice or Invoice.
System Cash Desk or Cash desk	It means the Ticketing location (terminal) where the Customer can purchase a Ticket for an Event.
Procedures	Procedures for the distribution of Tickets for Events as defined in Annex 3.
